I hereby agree to abide by the following rules:-

- All entrants must obey the directions of event officials at all times, and **park in the space/area allocated** to his/her vehicle, and conduct themselves in an orderly manner.
- All drivers must hold a current drivers licence.
- Any machinery which is thought to be unsafe in the opinion of the safety officer or his delegates, will be prevented from operating.
- Passengers are permitted on tractors (where the tractor has passenger seating as a standard attachment) at the discretion of the operator who shall be responsible for their safety.
- Standing on the drawbar or similar attachments while the vehicle is in motion is not permitted.
- **Children are not permitted to drive or ride on any motorised vehicle.**
- **No vehicle to exceed 10kph at any time.**
- All Tractors to be in the display area by 8 am
- All owners to register with the Tractor Steward at the time of delivery of Tractors to display area.
