Stall holders arriving before Thursday will be charged camping fees.

Operating Hours.

Show commences at 9 a.m. on Friday & 8 a.m. on Saturday.

Show closes at 5p.m. on Friday and 9 p.m. on Saturday (Pavilion stallholders may make arrangements to close at 6 pm Saturday.)

If Stall Holders must leave early, they must make prior arrangements with Space Steward, and be given an escorted exit off the grounds.

No un-escorted Vehicle movement is allowed on the grounds during operating hours
